Dear Judge Torres:

The parties respectfully submit this joint application to request a briefing schedule for motions to seal portions of the parties' filings in connection with their motions to exclude expert testimony (the "Exclusion Motions"). Oppositions to the Exclusion Motions are due on August 9, 2022, and replies are due on August 30, 2022.
